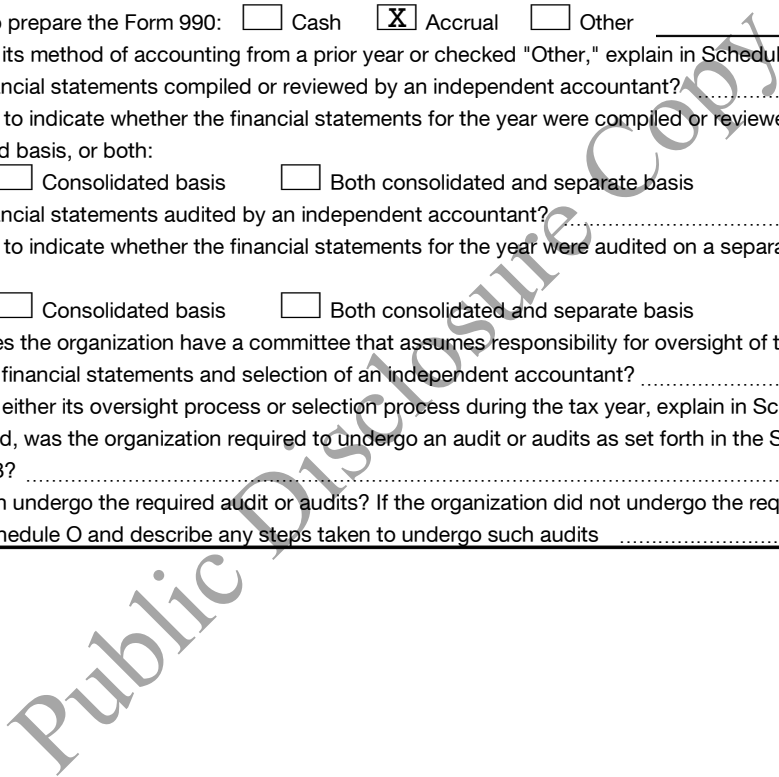

We review the written conflict of interest policy at the annual meeting (in May) and ask members to disclose any conflicts or issues that could be perceived conflicts.

They bring their recommendations to the board at the annual meeting and there is a vote. The Executive Director is excused from the meeting for this discussion and vote.
