1. The Entrant/Boat owner/Undersigned warrants and represents that they are empowered to enter a boat, whether owned or chartered, in the LAKE TARPON Holiday Boat Parade.
2. The Entrant/Boat owner/Undersigned agrees to comply with all rules and regulations governing the LAKE TARPON Holiday Boat Parade, as well as comply with the safety requirements, instructions and regulations of the United States Guard (Auxiliary), Sheriffs Department and Parade Committee safety vessels.
3. The Undersigned authorizes the parade organizers to utilize entrant name and parade photographs for publicity and waives and release any and all claims or causes of action arising from or related to publicity and media coverage.
4. The Undersigned is solely responsible for all costs and expenses and will maintain sufficient insurance to protect from all risks arising from the Agreement.
5. **ASSUMPTION OF RISK.** The entrant/boat owner/undersigned freely assumes all risks, including personal injury or death to myself and or my crew, loss or damage to the BOAT and its equipment as well as unforeseen risks.
6. **WAIVER, RELEASE AND INDEMNIFICATION:** TO THE FULLEST EXTENT PERMITTED BY LAW, THE ENTRANT, BOAT OWNER AND UNDERSIGNED WAIVES ALL CLAIMS, FOREVER RELEASES AND AGREE TO INDEMNIFY AND HOLD HARMLESS THE LAKE TARPON HOLIDAY BOAT PARADE, ITS ASSOCIATES, OFFICERS, AGENTS SPONSORS, EMPLOYEES, COMMITTEE PERSONS, VOLUNTEERS AND BOAT OFFICIALS ACTING IN THEIR OFFICIAL CAPACITIES, FROM ANY DAMAGE, LIABILITY, LOSS, COST OR EXPENSE, INCLUDING ATTORNEY FEES ARISING FROM MY AND MY CREW 'S PARTICIPATION IN THE LAKE TARPON HOLIDAY BOAT PARADE. INCLUDING BUT NOT LIMITED TO THE LAKE TARPON HOLIDAY BOAT PARADE'S ACTIVE OR PASSIVE, REGULAR OR GROSS NEGLIGENCE.
